RESEARCH STUDIES PROGRAM

Since its foundation in 1987, PASSIA has undertaken its Research Studies Program which to date has resulted in over 200 publications, researched and written by PASSIA team members or by specifically contracted researchers, who, over the years, have been as diverse as the subjects covered. Authors have included Palestinian, Arab, Israeli and international academics, scholars and experts.

In its efforts to provide background information, in-depth studies, and documentation on issues of concern as well as to promote a better understanding of the Palestinian cause, PASSIA maintains that all research and publishing are done within the context of academic freedom. PASSIA publications aim to be specialized, scientific and objective, yet they often address controversial or neglected issues and allow the expression of a wide range of perspectives.

PASSIA is proud that its publications have become a valuable reference source for academics, diplomats, professionals, libraries and anyone with an interest in Palestinian issues and their relations to regional and international affairs.

As part of its 2020 Research Program, PASSIA published a bulletin on *Israeli (Government) Institutions and Their Impact on Palestinians in East Jerusalem* and produced two explain videos, one on Palestinian residency rights in Jerusalem and one on the discriminatory Israeli planning regime. Israeli (Government) Institutions and Their Impact on Palestinians in East Jerusalem

English, 24 pages, November 2020

Israeli policy has aimed since 1967 to politically unite the city of Jerusalem and consolidate in it a Jewish majority, while maintaining in practice an economic disparity between the Arab and Jewish parts of the city. Consequently, Israeli policymaking regarding East Jerusalem - whether in national or municipal institutions – has been to the clear disadvantage of the Palestinian population, severely limiting their growth and development.

The organizational structure of the Israeli system does not enable suitable representation of Palestinian Jerusalemites, as the Palestinian Authority has no jurisdiction in Jerusalem, leaving Arab East Jerusalem in a state of limbo. This, paired with the centralization of power towards national Israeli authorities, result in a widespread ignorance or neglect of Palestinian rights and needs.



In many areas – especially in fields related to planning and infrastructure - there is also an overlapping involvement of local (municipal) and central (national) government and often additional other agencies. This cross-over between municipality and government complicates the bureaucracy and highly politicizes decision-making.

This bulletin attempts to give an overview of the landscape of Israeli institutions with which ordinary Palestinians are forced to deal with in their daily lives in East Jerusalem, over which Israel claims de jure sovereignty, and show how they are de facto structurally disadvantaged by the activities of these institutions.

Explain Video Planning Schemes

Anyone who wants to build in Jerusalem must submit first a Planning Scheme Application (including map, project details, land ownership statement) to the Israeli authorities, and in a second step, apply for a building permit. Palestinians in East Je-




rusalem face many obstacles and lengthy delays in the process of approval of a planning scheme, which this video explains.

Explain Video Residency Rights

PASSIA, English, December 2020

After the War of 1967, Israel conducted two censuses in the newly occupied territory (one in June by the Interior Ministry, one in September by the Municipality), in which only those

who were physically present within the unilaterally extended municipal boundaries were counted, registered, and granted Israeli identity cards as Jerusalem residents, while all others, regardless of the reason for their absence, lost their right to legally live in the city. Since then, Palestinians in East Jerusalem are considered "permanent residents," a status that entitles them to certain benefits (e.g., national and health insurance, free travel, access to employment in Jerusalem and Israel), but also subjects them to pay all taxes that Israeli citizens pay, and prevents them from leaving the country without travel documents ('laissez-passer') issued by Israel's Ministry of the Interior. Their residency status can also be revoked without due process under continuously expanding pretexts, which Israel has used ever since 1967 as a tool of forcible transfer to maintain a Jewish majority in the city. This video explains what it means for Palestinian Jerusalemites to be treated as immigrants, allowed to live in their city not by (birth)right, but by grace.



A Guide to Al-Aqsa Mosque (Al-Haram Ash-Sharif). PASSIA publication, Arabic (124 pages), 2020

This booklet intends to serve as an informative guide to Al-Aqsa Mosque and the monuments it encompasses, which have been under Hashemite custodianship since 1924. It provides background information to all those landmarks, including mosques, minarets, domes, arched gates, schools, corridors, gates, pulpits, platforms, Al-Buraq Wall, water sources and the Islamic Museum. In doing so great efforts have been made to reflect the essential Islamic narrative in response to the various attempts to falsify the historical and religious facts of this holy site.

DIALOGUE PROGRAM

Ever since its foundation, PASSIA has striven to promote free expression within Palestinian society and to foster a better understanding of Palestinian affairs, be they in the domestic or international context. In doing so, PASSIA has earned a reputation for providing a unique forum for dialogue and exchange and for serving as a catalyst for civic debate.

Central to these efforts has been the presentation and analysis of a plurality of Palestinian perspectives and approaches through PASSIA's Dialogue Program. Topics addressed and discussed cover a wide range of subjects broadly and specifically related to the Palestine Question, from historical aspects to the current Middle East Peace Process and internal Palestinian affairs.

The PASSIA Dialogue Program is composed of roundtable meetings, briefings and media. As part of the former, speakers are invited (and sometimes a discussant as well) to lecture on a certain topic, followed by a discussion with the audience present. These meetings aim to promote thought and debate among Palestinians and between Palestinians and their foreign counterparts. In order to accommodate a larger audience attending those meetings 'public lectures', most of them take place in hotel halls (in Jerusalem or Ramallah). Speakers, discussants and participants usually include local and foreign figures from a variety of backgrounds and schools of thought: scholars, professionals, officials and intellectuals from Palestine, Israel and abroad; members of Palestinian NGOs, political factions and the media, as well as representatives of diplomatic missions.

In comparison, PASSIA briefings are a venue for encounters, dialogue and discussions involving representatives and organizations from various backgrounds. These meetings typically focus on current Palestinian affairs and are designed to build bridges of communication and understanding between Palestinians from different streams of society and to develop constructive and focused academic contact between Palestinians and their counterparts. Briefings also include meetings in which resident diplomats, visiting foreign delegations or student groups from international universities discuss Palestinian affairs and exchange thoughts and opinions concerning the situation in the Palestinian Territories, as well as media briefings with resident and visiting correspondents and journalists. In return, PASSIA receives invitations to meetings with diplomats and visiting foreign dignitaries at other venues helping to consolidate relationships and forge connections between Palestinians and their foreign counterparts.



PROTECTING ISLAMIC AND CHRISTIAN CULTURAL HERITAGE IN JERUSALEM

This three-year project is jointly implemented by PalVision, PASSIA and ACT, and funded by the EU. It aims to develop and support the Palestinian East Jerusalem community and civil society's role in safeguarding their Islamic and Christian cultural heritage which is an integral part of the city's Palestinian identity. This will contribute to the strengthening of the overall resilience of Palestinian Jerusalemites and the preservation of the city's Palestinian character and support the historical, archaeological and cultural narrative that represents a true reflection of the city's Arab character. The Islamic and Christian Waqf properties play thereby a particularly important role and are in urgent need for protection due to Israel's ongoing attempts to monopolize Jerusalem's history and culture with its own ethnoreligious legacy.

The project's overall objective is to contribute to preserving the Palestinian character and cultural heritage of East Jerusalem by strengthening the Palestinian identity and enhancing the sense of belonging among Palestinians. More specifically, it aims at protecting Islamic and Christian religious and cultural heritage properties, including "Waqf", against Israeli violations and threats, as well as at enhancing Palestinians' ability to identify and value their cultural heritage and understand what can be done to protect it and the role it plays in preserving the Palestinian character of the city.







TRAINING SEMINARS

Training Program on Advocacy, Communication and Planning Skills

Building on its longstanding work in and on Jerusalem, PASSIA organized this training seminar to enhance the capacity and effectiveness of young Palestinians to successfully engage in advocacy, media and public awareness activities against the background of their threatened historic and religious heritage and culture in Jerusalem. Based on the notion that local stakeholders and the community play a vital role in protecting national heritage and identity, the course will provide participants with the knowledge, tools and skills to develop advocacy goals, strategies and campaigns for use at local and international levels. This training is part of the "Protecting Islamic and Christian Culture in Jerusalem" project which is jointly implemented by Palestinian Vision Organization, PASSIA and ACT, and funded by the EU.

Course Outline

- Preparation. Candidates interested in the training seminar had to complete and return PASSIA's application forms by the given deadline. Upon selection, participants had to confirm their commitment to full-time participation in writing. Selected participants were then provided with preparatory material and were required to complete a brief writing assignment on a subject related to the seminar.
- Intensive Seminar. The program took place from 13-16 September 2020 at the Legacy Hotel in Jerusalem. Due to the situation caused by the Coronavirus pandemic, the course was partly conducted online, i.e., those participants, who could not make it to Jerusalem in person, joined via Zoom. There were no costs involved for the participants. During the four-day seminar, key issues, concepts and practices of advocacy & lobbying, planning, and communication were introduced, focusing on the need to protect Palestinian culture and heritage in Jerusalem. The program included:

 - Effective Communication Skills
 - Analyzing the Context for Advocacy
 - Identifying Target Audiences & Messages
 - Advocacy Methods & Skills
 - Digital Advocacy (social media, new technologies)

RESEARCH & PUBLICATIONS

As part of the overall project, PASSIA engages in various research activities, including an in-depth **Monograph on the Waqf**, for which Dr. Haitham Suleiman from the Faculty of Law at Al-Quds University was commissioned. The book will inform about the history of the Jerusalem Waqf as well as its role and responsibilities vis-à-vis people and property, its current legal and other battles and challenges, and its connection with other authorities.

Another ongoing research component focuses on documenting in a **chronology of violations** assault against Al-Aqsa Mosque and other Islamic and Christian cultural heritage sites in Jerusalem. The chronology, which is updated on a regular basis is accessible on PASSIA's website (http://passia.org/wptimeline/).

Work also began on a **Bibliography on the Islamic and Christian Waqf Endowment in Jerusalem** which will list articles, books, theses, and other written works that deal with the history, evolution, and functions of the institution of the Waqf in Jerusalem and is hoped to be useful for any researcher or scholar interested in this field.

Work also commenced on a small database (to be used as a mailing list) of relevant local, regional and international religious and heritage-oriented organizations to keep them informed about the projects products and campaigns

In 2020 PASSIA already published an informational bulletin on *Palestinian Cultural and Religious Heritage in Jerusalem* (16 pages, English, October 2020 and Arabic, November 2020). The bulletin focuses on the Old City of Jerusalem, which is distinguished from any other historic city for its universal value. It is home to the most sacred religious shrines in the world, including Al-Aqsa Mosque/Al-Haram Al-Sharif, Al-Buraq Wall also known as the Western Wall, and the Church of the Holy Sepulcher. Within its walls, one can find numerous mosques, churches, convents, zawayas and mausoleums sacred to many believers worldwide.

Inscribed on the UNESCO World Heritage List (at the request of the Hashemite Kingdom of Jordan) since 1981, the Old City of Jerusalem and its Walls have a unique and valuable historic, religious and cultural heritage and



identity, that was skillfully built over centuries, and demonstrates the diverse urban and architectural styles developed over centuries. UNESCO's 1982 listing of the Old City as "World Heritage Site in Danger" is a testimony to the international concerns about the conditions threatening the integrity and survival of this outstanding spiritual place and its unique social composition.



This Bulletin endeavors to give an overview of the rich cultural and religious heritage in Jerusalem, the efforts that have been made to protect it and finally the challenges and threats that endanger the survival of the city's distinct Palestinian identity.

MAPPING OF PALESTINIAN YOUTH, MEETING, LEISURE, TRAINING AND OTHER YOUTH-RELATED CENTERS IN EAST JERUSALEM


PASSIA embarked on this project against the background that the current socio-economic and political situation in East Jerusalem is dire: lack of political representation, little economic opportunity and potential for growth, limited access to services, weak law enforcement, settler and police violence, and a restrictive construction and zoning regime paired with home demolitions and forced evictions – all of which creates a context that leaves little perspective for the Palestinians in general and the youth in particular.

Palestinian youth and young adults living in East Jerusalem do not currently have sufficient support to build the economic and social resilience that is vital given the living conditions that prevail in the city. There is thus an urgent need for immediate attention to redress this imbalance, *inter alia* by developing and enriching the services and programs provided by youth and youth-serving organizations, to improve the life chances of young people.

While there is a wide range of organizations in East Jerusalem dedicated to youth work or targeting youth in one way or another, it is often not clear who is exactly doing and what the unmet needs are. In order to fill this knowledge gap and improve awareness about the possibilities offered to youth and young adults in East Jerusalem, PASSIA conducted a detailed stocktaking of YSOs (meeting, sports, vocational and leisure centers), their areas of work, specific target group(s), needs and levels of networking.

This comprehensive mapping of existing resources and opportunities for youth in East Jerusalem provides a solid fundament for further strategizing, planning and programming, to avoid duplication of efforts and ensure that future projects start where the need is greatest.

Overall, 163 youth-serving organizations (YSOs) took part in the *Mapping of Palestinian Youth, Meeting, Leisure, Training and Other Youth-Related Centers in East Jerusalem,* which also produced a searchable online database and a report that provides a yet non-available overview of the organizations, programs and activities targeting youth in East Jerusalem as well as their perceived needs.

PASSIA DESK DIARY



At the end of 2020, PASSIA published the 33rd edition of its annual Desk Diary! As in previous years, the goal was to provide a comprehensive "tool" for all those who work in or on Palestine or are interested in the Palestine Question in which way ever. As every year, the current edition was updated, amended and revised according to new information that had become available throughout the year. On over 500 pages, the PASSIA Desk Diary contains a directory of contact information for relevant organizations operating in the West Bank and Gaza (listing names, addresses, main activities), as well as a full day-to-day planner (calendar) for the year, and a comprehensive compilation of facts and figures related to Palestine and

the Palestinians. PASSIA is very proud to say that its diary has become an invaluable source of information for many people, both locally and abroad, and as yet there is no equivalent publication in Palestine.

The PASSIA Diary is divided into three sections - the Directory, the Calendar, and the Agenda:

Directory:

The Directory contains details of Palestinian and international institutions operating in the Palestinian Territories as well as selected Arab and Israeli organizations located in Israel: names of contact persons, phone and fax numbers, e-mail and mailing addresses, websites, and a few keywords describing an organization's main field of work. At the end of the directory there is an alindex phabetical to facilitate searches for certain entries. In the


